I understand that I may have opportunity to participate in some or all the following activities and that there are additional physical risks associated with each of these activities. I acknowledge and assume all the risks for myself associated with all camping activities as well as the additional physical risks for me associated with each of the following activities: Hiking, Swimming, Low Adventure Course, Climbing Wall, Mountain Biking, Canoeing or other boating type activities, Field Sports, and Horseback Riding* (*which also requires a separate Liability Release form).

The undersigned further releases Beaver Creek Camp Commission, its directors, employees, and volunteers from any and all actions, causes of actions, liabilities, claims, demands, costs and attorney's fees incurred by me by reason of damage, loss, injury, or suffering which may occur on or in connection with Beaver Creek Camp activities. Further, the undersigned agrees to indemnify and save harmless Beaver Creek Camp Commission, its directors, employees, and volunteers against any and all liabilities, loss, damages, costs and expenses which the said Beaver Creek Camp Commission, its directors, employees, and volunteers may hereafter suffer or incur by reason of any claim for personal injury or property damage or claims of any kind or nature whatsoever made by any person including the camper identified above, arising out of injuries or damages or both sustained by the camper identified above which may occur on or in connection with activities of Beaver Creek Youth Camp.

I understand that campers may not have/use cell phones or internet accessible devices while at camp. I agree that I will act in a responsible way, respecting other people, as well as camp property and facilities. I understand that my participation in camp may be terminated if I act in a negative or threatening manner towards other people or the camp property.
